reating award-winning orchid exhibits eludes the grasp of many: They feel that they are not "artistic" enough. Although being an artist may help, it is not a necessary prerequisite for putting together a beautiful...even an awardwinning exhibit. An understanding of AOS judging criteria is fundamental if you seek official recognition of your efforts. Of course it helps if you have a selection of high quality orchids and a little imagination. Here you'll find guidelines for determining the number of orchids and foliage plants you'll need, suggestions on groundcover materials, an explanation of color flow, staging techniques, a checklist so you won't forget that one important item.

If you are a member of an orchid society and scheduled to be putting in an exhibit at a show this year now you can be the hero. If you have been lurking in the background lacking the neccessary confidence to take the plunge, read these pages. Exhibit work can be dirty, tiring, fun and very rewarding. If you are a student judge there is useful information for you here as well. Use the checklist. If you are a hobby grower who has been considering doing an exhibit someday, now is the time.

AOS point system for judging exhibits:

The American Orchid Society Handbook on Judging and Exhibition provides the following point scale for judging.

Groups of Plants or Cut Flowers Arranged for Effect.

This point scale is similar to ones used by horticultural organiza-

A0S President's Communication: Altering Course

n the economic climate in which we find ourselves these days, we are all faced with difficult decisions when it comes to where and how we spend our money. Well, the AOS is no different. The Board of Trustees recognizes that our organization's Mission must be the focus, and at the same time we must understand who our member are, and what is required to do for our members to remain a viable organization. It is obvious that we must do what private and public institutions do, as well as what many families do. And that is, we cannot spend what we do not have.

With this in mind, the Board of Trustees and management took a very deliberate look at everything we are doing and determined whether each component adds value to the majority of the membership and whether it could be sustainable as a stand-alone program. As I explained in my last month's column, our magazine, Orchids, is the most important reward for being a member of this can continue to produce a monthly publication. In the same manner, judging and the Web site were determined to be as important as the magazine.

However, we came to the conclusion that the gift store and the gardens, both located in our headquarters in Delray Beach, Florida, were two areas that could not meet the criteria on an ongoing basis. Therefore, the Board instructed management to begin a wind-down of the gift store immediately. As far as the gardens are concerned, we want to make sure that we can meet our obligations with the special events that are under contract and are scheduled through the end of May. Then in June we will close the gardens and greenhouses to the public, while still maintaining them to protect the value of that investment. Again, I repeat, the gardens will not be disbanded or individual plants sold. On the contrary, the gardens will be maintained with reduced staff and with the help of volunteers, so when

Culture Tips by Al Clinton
rchid's Full Name: Dracula
felix.

Watering: Keep moist but not soggy. Likes frequent, light misting.

Temperature (include info on differential temp needs): Having cool temps is the key ingredient. I'm growing it in our north facing plant room. Winter 58 to 65 degrees. Can

take warmer temps in the summer (80s) but doesn't like it.

Light: Lower light, like a Masdevallia or Phalaenopsis.

Fertilizing: One-fourth dilution of DynaGrow 7-9-5 weekly.

Atmosphere (i.e., breezy or not, etc.):
Breezy and high humidity.

Special features (i.e., scented, etc.): This species is known for its abundance of flowers. This one had

about 105 flowers when shown at the February meeting.

Other helpful and/or interesting information about this orchid: Felix will be traveling to St. Louis with Mark Prout for the March 7th AOS judging.

we come out of this financial crisis they will reopen to the public, as the gardens are an important part of our recently implemented strategic plan.

We continue to face extraordinary economic times, and we will continue to take steps to operate with the income we are receiving. This means that we will continue to make cuts in programs and personnel to match the money available. The Board has instructed management that it must operate within these limits, and under no circumstance take money from investments.

At this moment, we are doing all we can to maintain services, and at the same time look for ways to increase the value of what the members receive for their membership. We need your help in getting new members and in securing donations, which are fully tax deductible, as dues alone are not enough to provide all the services to you.

But there is good news in these difficult times, as we have a head-quarters that is fully paid for and a corps of volunteers, who together with the reduced staff, can help us serve our membership. The Board of Trustees is in continued contact with management to make sure we stay focused on our Mission and serve the membership while keeping a prudent look at how we operate on a month-to-month basis.

As a postscript to last month's column, I mentioned that we were no longer funding any grants for this fiscal year. This does not affect the private funding of fellowships and applications will be reviewed at the Spring Members Meeting. For example, the Furniss and Fang foundations still will consider worthy applications for their generous gifts to qualified applicants.
